



I worked with Curtis Reeves at the Tampa Police Department from the early 1970's until my retirement from there in 1992. Together we created the Tactical Response Team (Tampa's version of SWAT). Curtis insisted we get our tactical training from the FBI, and Sniper training from the United States Army, so as to have the best preparation for forming a team that would serve to protect the public in highly dangerous situations. As a result of our training and diligence our team earned national recognition. I point this out so it can be seen that Curtis was a professional police officer who dedicated his entire career to help improve the police department. His continuing concern was for everyone to do the job well, in order to best protect the public we served. Eventually, in 1992 I retired from the Tampa Police Department and went on to the Hillsborough County Sheriff's Office as the Chief Deputy. When Curtis retired in 1993 I recommended him for the job of Security Director at Busch Gardens, precisely because he had been so professional during his career at the Tampa Police Department.

On all of the numerous dangerous situations we were involved in together, I always witnessed Curtis exercising restraint when called for, and action when needed. Never did I see him act outside his training or our department policy. He demanded the same excellence from his officers that he demanded from himself. And, would not allow anger or emotion to effect his, or others, actions.

I haven't stayed in contact with Curtis since his retirement from Busch Gardens except to see him at a funeral for a mutual friend last year. He seemed content in retirement and spent most of the time during the funeral occupied with his toddler granddaughter at the back of the church. Curtis' connection with his family, friends, church members and all other activities he's involved with are all within the local area. I'm not aware of any large accumulated wealth he might have. I have known Curtis Reeves since 1982. When I first met him I was a young officer with the Tampa Police Department and Curtis was a lieutenant in my assigned district. Originally our relationship was just work related. Curtis was the commander of the SWAT team and I was eventually made a SWAT team member. It was at this time that I really got to know Curtis and became personal friends with him. Curtis became my mentor and I have great respect for him and the way he presented himself as a commander. I attempted to model myself after him. My wife and I became very good friends with Curtis and Vivian. We spent weekends at the beach with them and regularly have dinner with them either at a restaurant or at one of our homes. Curtis retired from TPD about 20 years ago, and my wife and I continued to stay in contact with him and Vivian by having dinner with them on a regular basis.

Reference to Curtis as a commander of the SWAT Team and Uniformed Patrol Division commander; it is my observation that he was considered the go to guy when any type of significant incident such a civil disorder or barricaded person occurred. He was also involved in most of the training that occurred within the department. Curtis is a very intelligent and well trained police officer. It is my observation that he has always practiced outstanding judgment in stressful situations. I have worked numerous barricaded person operations with Curtis as a SWAT member and personally seen Curtis save lives through his tactics and leadership as a commander. This was personally observed by me during many SWAT operations that both of us were involved in.

In my opinion Curtis has very high moral standards. He is a religious person that attends church on a regular basis. He is well spoken and never uses profanity. He has very strong family ties and he has always spent a lot of time with his wife and children.

As a neighbor and fellow church member, Curtis has always displayed the highest of moral character and principles of right and wrong.





I met Captain Reeves almost 40 years ago when he was the commander of Tampa Police Department's first SWAT team.

During that time I was under the command of Captain Reeves & Major Tom Depolis.

During the first 2 years of the SWAT team, we did not have crisis intervention negotiators. This duty fell to Captain Reeves & Major Depolis. Many times I watched Captain Reeves talk to people who seemed beyond approach to any logical conversation, slowly calm down. Sometimes this took hours but Captain Reeves had the ability to listen and respond to their needs in a way that diffused potentially violent or suicidal people. In nearly all of those situations, almost all of the incidents resulted in surrender with no need of a violent conclusion.

Throughout my career I considered Captain Reeves a mentor who was always available to anyone in need of counsel. His advice was always sound, logical, and delivered in a positive way.

After retirement we remained friends and our families socialized. We fished, hiked, hunted, and went to dinners & movies. On occasion we vacationed together.

In conclusion I have observed Captain Reeves interact with people under the worst of circumstances during our careers and retirement.

Never once did I witness Curtis Reeves lose control of his temperament and command presence during his career. I participated in many physical fitness training sessions for specialty team members and Curtis Reeves was the lead instructor. I listened to Curtis Reeves change the mindset of those officers who were not participating in the training sessions seriously, gaining their cooperation with words, not physical force. He spoke in a normal tone of voice, even when disciplining subordinate officers, gaining their compliance without resorting to yelling obscenities at them. Curtis Reeves has for decades been a well respected, honest and trustworthy member of his community, with numerous family members and friends surrounding him.
